Regulations on time standards for planning the academic workload of the teaching staff of Karaganda University named after E.A. Buketov

1. These regulations define the time standards used in planning the academic workload of the teaching staff (hereinafter referred to as "teaching staff") of the departments of Karaganda University named after E.A. Buketov.

2. The academic workload is assigned to the teaching staff by the head of the department individually, depending on the staffing, qualifications, and profile of the department.

3. The volume of classroom workload of the teaching staff by position is carried out in accordance with the "Qualification Professional Standard of the teaching staff of NAO Karaganda University named after E.A. Buketov".

4. The ratio of classroom and extracurricular workload is determined by the head of the department independently, taking into account the approved staffing, the average pedagogical workload of the department, the profile of the department (degree-granting or university-wide), the qualifications of the teachers, and the position held by the teaching staff.

5. Educational work of teachers with students is subject to hourly payment if there is an approved schedule in the following cases:

· Retakingcourses;

• Eliminating the academic difference in work plans upon reinstatement and transfer;

 Mastering the program of pedagogical training for graduates of specialized master's programs.

6. The calculation of the academic workload of the teaching staff should take into account the following time standards by type of work¹:
