## **1. GENERAL PROVISIONS**

1.1. This Regulation on the International Online Olympiad in International Financial Reporting Standards (hereinafter - the Regulation) defines the goals, objectives, procedure, conditions for holding, participation and summing up the results of the competition.

1.2. Olympiad organizer: Karaganda University named after Academician Ye.A. Buketov, Faculty of Economics, Department of Accounting and Audit.

1.3. Partner of the Olympiad: POB "Union of Accountants and Accounting Organizations of Kazakhstan"

1.4. Management, preparation and conduct of the Olympiad is carried out by the Department of Accounting and Audit of the Karaganda University named after academician Ye.A. Buketov.

1.5. Languages of the Olympiad: Kazakh, Russian, English.

1.6. Carrying out form: remote.

1.7. Information about the preparation and holding of the Olympiad is posted on the website of the KarU named after academician Ye.A. Buketov - <https://buketov.edu.kz> and social networks at the addresses:

## **2. GOALS AND OBJECTIVES OF THE OLYMPIAD**

2.1. Goals of the Olympiad:

– improving the quality of training of qualified specialists, developing the creative abilities of students, as well as increasing students' interest in educational activities and future profession;

– promoting the professional growth of gifted students and involving them in continuing their education at the master's level in the educational program "Accounting and Audit".

2.2. Objectives of the Olympiad:

– stimulation of educational-cognitive and educational-research activities of students;

– disclosing the professional and personal potential of students, their self-awareness, creating conditions for self-realization and self-affirmation;

- develop practical skills in accounting in accordance with international financial reporting standards;

– support of the most talented and gifted students;

– increasing students' cognitive interest in international financial reporting standards;

– improving the quality of training future qualified specialists in the field of accounting;

– stimulation of educational, cognitive, research activities of students in the field of accounting;

- the development of personal skills among the participants of the Olympiad, which increase the human capital of future qualified specialists;
- popularization of scientific and practical knowledge among students;
- strengthening ties between the teaching and student communities of leading universities in the field of economic sciences.

### **3. PARTICIPANTS OF THE OLYMPIAD**

3.1. The Olympiad is an intellectual competition in accordance with international financial reporting standards for senior undergraduate students (2-3-4 courses) of higher educational institutions of the Republic of Kazakhstan and foreign countries.

3.2. Participation in the Olympiad is voluntary and free for participants.

3.3. Participation in the Olympiad is individual.

3.4. The organizing committee has the right to demand documentary confirmation of the corresponding status of the participant of the Olympiad (certificate from the educational institution confirming the status of the student indicating the course of study, student card, grade book, etc.).

### **4. PROCEDURE FOR ORGANIZING AND HOLDING THE OLYMPIAD**

4.1. To conduct the Olympiad, an Organizing Committee (hereinafter referred to as the Organizing Committee) and a jury are created.

4.2. Members of the Organizing Committee and the jury are formed from the teaching staff of the Department of Accounting and Audit of the Faculty of Economics of the Academician Ye.A. BuketovKarU, graduates of the Faculty of Economics of the AcademicianYe.A. BuketovKarU, working in the specialty, representatives of research organizations and business - communities and are approved by the order of the Chairman of the Board - the Rector of the University.

4.3. The Chairman of the Organizing Committee of the Olympiad is the Chairman of the Board - Rector of the KarU named after academician Ye.A. Buketov.

4.4. The operational management of the Olympiad is carried out by the Deputy Chairman of the Organizing Committee or the Executive Secretary. The composition of the Organizing Committee and the jury is approved by the order of the rector.

4.5. The organizing committee performs the following functions:

- approves the rules of the Olympiad;
- forms the composition of the jury, taking into account that simultaneous membership in the jury and the organizing committee is not allowed;
- provides direct holding of the Olympiad events;
- approves the list of winners and prize-winners of the Olympiad;
- awards the winners and prize-winners of the Olympiad;

- provides free access to the regulations and information about the schedule of the Olympiad, the composition of participants, winners and prize-winners;
  - develops assignments and a set of teaching materials for teachers and students;
  - determines the criteria and methods for assessing completed assignments;
  - performs other functions aimed at achieving the goals of the Olympiad.
- 4.6. The jury of the Olympiad performs the following functions:
- checks the results of the individual tasks of the participants of the Olympiad;
  - determines the nominations of winners and prize-winners of the Olympiad;
  - submits to the Organizing Committee proposals for improving the organization of the Olympiad;
  - performs other functions aimed at achieving the goals of the Olympiad.
- 4.7. The decisions of the jury of the Olympiad are recorded in the minutes and submitted to the Organizing Committee for the preparation of an order on the final results.
- 4.8. The jury's decision is final and not subject to appeal.

## **5. REGULATIONS OF THE OLYMPIAD**

5.1. The content and complexity of the competitive tasks of the Olympiad correspond to the educational program "Accounting and Audit".

5.2 The Olympiad consists of two rounds: 1 - testing, 2 - solving situational tasks.

**The first round is** the performance of test tasks, which include 30 questions with one correct answer. The time allotted for this task is 30 minutes. Each participant is tested online at the link: **e.ksu.kz** (Olympiad "International Financial Reporting Standards"). To participate in the testing, all participants will receive logins and passwords from the organizing committee (by e-mail specified in the participant's application).

**The second round is "Solution of case tasks"**. Participants who have successfully passed the test are allowed to the second round of the Olympiad.

The solution of case tasks is sent in electronic form (scanned) to e-mail: [ksu.bua@mail.ru](mailto:ksu.bua@mail.ru) . Indicate in the **subject of the letter**: “**Olympiad\_Name of the university, full name of the participant**”. Submit the decision electronically.

5.3. Competitive documents are kept by the Organizer and are not returned back.

5.4 Participants of the Olympiad at each of the rounds receive points, which are then summed up.

## **6. SUMMARY**

6.1. Summing up the awarding of the winners is carried out by the Organizing Committee of the Olympiad on the proposal of the jury.



6.2. The participants with the highest average total points are recognized as winners.

6.3 The winners of the Competition are awarded with diplomas of the winner of I, II, III degrees, scientific supervisors - with letters of thanks.

6.4 The Contest Committee has the right to approve additional nominations for awarding participants in the Contest. Availability and number of seats are not regulated by these Regulations.

6.5 Diplomas and letters of gratitude will be sent to the supervisors at their email addresses.

6.6. All controversial issues or issues outside the scope of this regulation or regulations are resolved promptly by the Olympiad Organizing Committee. The decision of the Chairman of the Organizing Committee on such issues is final.

6.7. The results of the Olympiad will be posted on the official website of KarU named after Ye.A. Buketov, social networks at the addresses: Instagram: @kafbuch, @economksu.

6.8 The content of the materials sent to the competition should not contradict the legislation of the Republic of Kazakhstan. Content that offends the dignity and feelings of other people will not be accepted.

6.9 The participant (team) and the supervisor who sent the work to the Olympiad are responsible for the observance of copyrights for the works participating in the competition.

6.10 The organizers have the right to use the submitted materials for open placement on the university website and social networks.

## 7. ORGANIZATIONAL POINTS

7.1 To participate in the Olympiad, universities submit an application to the organizing committee of the Olympiad in electronic form in the form specified in Appendix 1 of these Regulations by e-mail: [ksu.bua@mail.ru](mailto:ksu.bua@mail.ru) . In the subject line, indicate “**Application\_Name of the university**”. After registering the application, participants receive logins and passwords to participate in the Olympiad (to complete test tasks).

7.2 Participation in the Olympiad is individual. Participants are admitted to the Olympiad according to the application of the university. It is possible to replace the declared participants who are absent for a good reason, at the suggestion of the head of the participant, no later than the end of registration.


