Research result 2 is partly new. Based on the analysis of methodological and scientific literature, an algorithm of the methodical processing of authentic audio- and videomaterials as the digital educational content is considered and substantiated to integrate them into the environment of a foreign language multimedia tutorial.

Research result 3 is new. The author has developed a technology of creating multimedia educational tutorials based on authentic audio- and videomaterials, based on the existing theories of creating electronic resources, educational presented methodological foundations, provided and disclosed substantiation of its definition and essence as a system of notions, actions and procedures, built in accordance with the principles and requirements for the process of developing these multimedia tutorials. including theoretical and technical aspects of their creation.

Research result 4 is new. The author has developed and tested a methodical system aimed at training pre-service foreign language teachers to create multimedia educational tutorials based on authentic audio- and videomaterials, consisting of interrelated components that ensure that in their unity they achieve the sufficient (heuristic) and high (professional) levels of readiness for this type of activity which involves their acquisition of deep knowledge and competencies in the specified area.

Research result 5 is new. Approbation of the methodical system aimed at training preservice foreign language teachers to create multimedia educational tutorials based on authentic audio- and videomaterials allowed most students to achieve a sufficient level of readiness in this area and implement a systematic approach to creating multimedia educational tutorials in terms of Pedagogy, Methods of Teaching, Psychology, Ergonomics.

Positively evaluating the results of the dissertation research conducted by Smagulova Gulnur Zhumartovna, we suggest some recommendations:

- 1. The reserch focuses on pre-service foreign language teachers' achievement of a sufficient (heuristic) level of readiness in the field of creating multimedia educational tutorials based on authentic audio- and videomaterials s, while it might be necessary to strive to achieve a high (professional) level of their readiness in this area.
 - 2. There are some stylistic and punctuation flaws in the text of the dissertation.

It should be noted that the above remarks are mostly of a formal character and do not reduce the significance of the research carried out and the results obtained, presented in the dissertation work.
