She began her career in 1997 as an investigator of the Department for the Investigation of Crimes against the Person (ORPPL) of the Investigative Committee for the city of Temirtau. While in this position, he had no penalties, was encouraged by the rights of the head of the GSK in the Karaganda region. In 1998, he was recommended for the position of a teacher of the cycle of special disciplines of the School of the Ministry of Internal Affairs of the Republic of Kazakhstan for vocational training (Temirtau). In 2000, he was invited to the position of lecturer at the Department of Criminal Procedure of the Karaganda Law Institute of the Ministry of Internal Affairs.

In November 2002, he entered the full-time adjunct of the Ministry of Internal Affairs of the Republic of Kazakhstan named after Barimbek Beisenov, which he graduated in October 2005.

On June 30, 2006, in the dissertation Council OK 14.20.07 of the CUI of the Ministry of Internal Affairs of the Republic of Kazakhstan named after B. Beisenov, he defended his thesis for the degree of Candidate of Legal Sciences on the topic: "Elimination of the consequences of moral harm in criminal proceedings of the Republic of Kazakhstan" in the specialty 12.00.09 "Criminal procedure, criminalistics, theory of operational investigative activities, forensic examination", by the decision of the CCSON of the Ministry of Education and Science of the Republic of Kazakhstan dated 29.11.2006, the academic degree "Candidate of Legal Sciences" was awarded

From November 2005 to 2011, he worked as a teacher and senior lecturer of the Department of "Organization of Crime Investigation", from January 2011 to August 2012 he was an associate professor of the Department of Criminal Procedure, and after passing an extraordinary certification, he was appointed in September 2012 to the post of head of the Department of Criminal Procedure of the Karaganda Academy of the Ministry of Internal Affairs of Kazakhstan named after Barimbek Beisenova. During his work at the Karaganda Academy of the Ministry of Internal Affairs, he was awarded a diploma of the Minister of Internal Affairs of the Republic of Kazakhstan, a letter of thanks from the Minister of Internal Affairs, won the nomination "Best

Curator" in 2006, "Young Scientist of the Year" in 2007. In 2011, he was awarded the highest qualification "Specialist Mentor".

From February to November 2014, he was a senior inspector on special assignments of the Department of the Organization of Departmental Education of the Ministry of Internal Affairs of the Republic of Kazakhstan in the field of science (Nur Sultan city).

Bachurin was included in this group and I have prepared a commentary to chapter 48 of the said Code. In December 2021, the comment was posted on the state portal of the Republic of Kazakhstan.

In addition, in June 2014, in connection with the reform of the penal enforcement legislation, by Order of the Minister of Internal Affairs of the Republic of Kazakhstan No. 315 dated 02.06.2014 "On the working group of the Ministry of Internal Affairs of the Republic of Kazakhstan on the preparation of a Commentary to the Penal Enforcement Code of the Republic of Kazakhstan, S.N. Bachurin was included in this working group.

In May 2014, S.N. Bachurin was accredited as a subject of scientific activity to participate in scientific research at the expense of the state budget.

During 2017-2018, he carried out business trips to participate in international conferences in St. Petersburg, Krasnodar, Novorossiysk, according to the results of which scientific articles were published.
